## AFRICA CHRISTIAN TRAINNING MINISTRY REPORT

Dear Board members I was unable again to make it to this year's board meeting as I had wished.

We have had a very busy year, we thank every one who has supported the ministry here with Prayers, finances and most especially those who were able to travel and serve here with us physically.

\*As I stated in my last year's report that although most of the wires are channeled through Pr Bob Hayes ,some supporters wire money directly to our account this causes a discrepancy between our Income and the income on the US side.

- \* The funds that are wired here are mainly designated towards the following:
- 1. Gifts: These are sent to widows, students and the needy.
- 2. Pastor's Stipends: Many of our churches are not able to support their Pastors; some Pastors in Uganda receive stipends from our friends across the ocean.
- 3. Tuition: Many needy students are supported with tuition through ACTI.
- 4. Charitable organizations: Some Charitable organizations like the Bethel Orphanage receive funds through ACTI.
- 5. The Missions figure in the Income statement includes Evangelism, Seminars and other ministries through ACTI.
- 6. Support to teachers: Christian schools in Uganda receive no support from the government, they are therefore not able to pay their teachers especially the last month of the year, some individuals have begun to support some of the Teachers in the Christian Schools here in Uganda.
- 7. Africa Christian Training Ministry has two field personnel that are paid: Pastor Rashid Luswa Kisegerwa and Sam Bongole Kibuuka, Salaries for 2012 have been fully paid until December 2012; we thank you so much for this support.
- 8. Development: These funds include construction of Schools, Churches, construction of orphanages etc. Funds take between two to five days to reach the recipients. We thank you so much for the Support may the Lord bles
- 9. This year schools have been supported with construction ,Bore holes have been dug and church structures have been raised ,all this has been reflected in the development project figure on the Income statement
- 10. Some organizations, Churches and individuals receive money through ACTM, our duty here is to pass on this money to them in a lump sum with a small charge, accountability is therefore done by the recipients to donors.
- 11. The Petty Cash expenses figure includes the money we spend on feeding, stationery, gasoline, and telephone for our Office in Uganda.
- 12. The Benevolences account includes the money that ACTM gives to the sick ,people without rent, food etc.
- 13. A substantial amount of money has been spent on counseling, Conferences, Evangelism, Prison ministries and the School of Evangelism

We again thank all the Churches, organizations and Individuals for the continued financial, physical and moral support.
